There was a successful spring trout stocking at Sunrise Lake, with 348 fish that measured between 10-12 inches, 15 fish that were 15 inches long, and 4 fish at 20 inches long. As always, catch and release is encouraged with a two fish per day limit. All members and guests fishing at the lake will be required to have proper identification for lake access. Beach News

Pavilion Reservations

To reserve the pavilion, call Rich – 303-550-5869 or Kristy - 303-519-2507 **any time after the beach cleanup on May 13th.** A \$50 deposit is required in addition to the \$25 rental fee. A rental agreement will be provided to the renter, the signed agreement and payment must be received within 7 days or the reservation will be cancelled. The deposit will be returned if the renter complies with the terms of the rental agreement.

Beach Hours:

The official opening of the beach is Memorial Day weekend, weekends only, through the second or third week in June. The beach will open daily after the end of the school year subject to the availability of lifeguards.

Water Safety Testing:

Will be performed weekly throughout the summer months. Results will be posted on the bulletin board at the bath house.

Lake and Beach Water Treatment

We continue to utilize Ecological Solutions, Inc. to manage various lake and beach weeds as needed throughout the season.

We have been treating the swimming area with Muckaway in order to reduce the buildup of detritus (muck) and brown sediment on the sand in the swimming area. We saw a reduction in muck throughout last season and we will continue to treat for muck throughout this year.

Wristbands

Anyone using the beach or lake is required to display a wristband to identify themselves as an active member of WHP or the guest of an active member. This is an effort to prevent the unauthorized use of our facilities. Wristbands, three per family, will be distributed to active members at the general meeting or can be obtained from any Board member. Active members are those who have paid the current year's dues and have no balance past due. Wristbands are orange for the 2023-2024 season.

New Dues Payment Option

Due to requests from some homeowners, PayPal has been added as a payment option to pay your homeowners dues. There will be a service fee of \$12 for homes and \$10 for lots to pay your dues. No service fees are charged for checks and money orders. Instruction for the PayPal option is attached to your bill. We are continuing to look for better service fee rate. State of White Haven Poconos 2023

This past year we have continued with the repairs, replacements, and maintenance of the many of the issues outlined in the reserve study done by Eagle two years ago. The gate valve pier, by the dam, was refurbished and reinforced. This was a project not only required by the Pennsylvania DEP but needed to ensure the safe operation of the dam and the ability to maintain our lake.

The two docks by the boat area were replaced this year. The footings of the original docks were failing creating an unsafe situation and the original docks were showing their age. The replacement docks are floating docks decked with composite material that not only looks good and will be long lasting, but it will also prevent splinters.

Additional trout were stocked this spring, we had a successful picnic, and electronic payment of dues was set up through our website. We have continued a more aggressive approach to weed and muck management for the beach and lake and continued with repairs of Sunrise Lake Drive. Additional sand for the beach is planned prior to the summer season.

Unfortunately, as discussed at the last two Annual Meetings and agreed upon by a member vote, a dues increase is again needed. The current budget shows a balance of \$6328.57 remaining from April through the end of our fiscal year June 1. This amount does not include normal operating expenses and the additional expenses of sand for the beach and repairs to Sunrise Lake Drive, both planned for this spring. These projects will likely create a deficit of over \$5,000 for the fiscal year. With a \$25 per year increase, along with continued thoughtful and frugal spending, it is the Board's hope that we will be able to not only maintain but improve White Haven Poconos in this and future years.

Mountain Ash Road Storage Building

The community that we now know as White Haven Poconos was developed on a property which was previously owned by Atlas Powder Company, an American explosives and chemicals company. Atlas owned property up and down the north and south banks of the Lehigh River. Atlas utilized the river water to heat and cool the processes for manufacturing gunpowder and dynamite during World Wars 1 and 2. If you walk around the Lehigh Gorge State Park, you may be lucky enough to come upon the old boiler house, a mule powered mill post, steam piping, building remains and other structures which are distributed along the banks of the river.

One of these structures, located across from 2034 Mountain Ash Lane, is owned by the WHP Association. The structure was an explosive material storage facility, which the writer believes is best described as a bunker... It is a brick-and-mortar structure with sand filled walls and roof designed to limit the impact of an explosive event... The structure has no windows, water or electric service, and is located on a $\frac{1}{2}$ acre lot. WHP has historically used the building as a junk storage facility.

The reason for this history lesson is that the reserve study the board commissioned a few years ago has programmed some repairs and maintenance activities to keep the building from decaying. Recommended maintenance includes roof repair/replacement and the removal of brush and trees which are growing too close to the structure. As the BOD discussed the budget and potential repair costs for the building, we began to question the value in trying to preserve the building.

The BOD would like to take some time during the annual meeting to discuss options for the building and lot. Options include 1) performing required maintenance in order to preserve the building at a cost of approximately \$45K, 2) allowing the building to slowly decay and eventually collapse, 3) selling the building and lot together, 4) demolishing the building and selling the lot, 5) you let us know your thoughts....We will see you at the meeting.

Burn Ordinance

There is a burning ordinance in Bear Creek Township. Burning is only allowed in an enclosed area such as a burn barrel

Outstanding Dues

Disabled Motor Vehicles

Bear Creek Township has an Ordinance Prohibiting the storage of Disabled Motor Vehicles. Any motor vehicle possessing one or more of the following characteristics is in violation of this ordinance and is subject to removal:

- A. It is inoperable and has been stored in a residentially zoned area within Bear Creek Township for more than seven days.
- B. It lacks an engine, one or more tires or other essential part.
- C. It is kept in such a condition as to become a haven for vermin.
- D. It is maintained in a precarious or dangerous position of location.
- E. It has broken glass or other sharp edges.
- F. It presents a threat to the health, safety, or welfare of the public.
